2. **NOTE 1:** A completed copy of FAR 52.212-3 REPRESENTATIONS AND CERTIFICATIONS – COMMERCIAL ITEMS will be required upon notification that the contractor has been awarded the purchase order.

(a) *Definitions.* As used in this clause—

(1) “Contract financing payment” and “invoice payment” have the meanings given in section 32.001 of the Federal Acquisition Regulation.

(2) “Electronic form” means any automated system that transmits information electronically from the initiating system to all affected systems. Facsimile, e-mail, and scanned documents are not acceptable electronic forms for submission of payment requests. However, scanned documents are acceptable when they are part of a submission of a payment request made using one of the electronic forms provided for in paragraph (b) of this clause.

(3) “Payment request” means any request for contract financing payment or invoice payment submitted by the Contractor under this contract.

(b) Except as provided in paragraph (c) of this clause, the Contractor shall submit payment requests using one of the following electronic forms:

(1) Wide Area WorkFlow-Receipt and Acceptance (WAWF-RA). Information regarding WAWF-RA is available on the Internet at <https://wawf.eb.mil>.

(2) Web Invoicing System (WInS). Information regarding WInS is available on the Internet at <https://ecweb.dfas.mil>.

(3) American National Standards Institute (ANSI) X.12 electronic data interchange (EDI) formats.

(4) Another electronic form authorized by the Contracting Officer.

(c) If the Contractor is unable to submit a payment request in electronic form, or DoD is unable to receive a payment request in electronic form, the Contractor shall submit the payment request using a method mutually agreed to by the Contractor, the Contracting Officer, the contract administration office, and the payment office.

(d) In addition to the requirements of this clause, the Contractor shall meet the requirements of the appropriate payment clauses in this contract when submitting payment requests.

SPECIFICATIONS FOR AIRCRAFT STRIPPING BOOTH

1. Stripping booth shall be designed to provide an effective and efficient dry paint stripping facility suitable for use with plastic media. The booth will be housed in a weatherproof building that is separate from this acquisition. Major components of the facility are: Blast Room Equipment, Media Recovery Vacuum System, Media Cleaning System, Pressure Blast Equipment, Operator Safety Equipment, Dust Collection System, and Electrical Control Panel. In addition to the major components the booth shall meet the following requirements:

- a. Blast room dimensions are: 60' Long X 30' Wide X 30' High
 - b. Ventilation Velocity: 50 feet per minute
 - c. Walls: Galvanized steel, 10 gauge
 - d. Ceilings: Galvanized steel, 10 gauge
 - e. Personnel doors (2)
 - f. Lighting: Dust tight lights
 - g. Media recovery system: High Vacuum, media recovery including:
 - 1) Motor and Blower
 - 2) Separator
 - 3) Dust Collector
 - 4) Storage Hopper
 - 5) Pick-up Wands and Hoses
 - h. Media Cleaning
 - i. Media Separator
 - j. Pressure Blast Machine (2)
 - k. Media Flow Valve
 - l. Abrasive cut-off switch
 - m. Blast Hose and nozzle
 - n. Operator remote controls
 - o. Operator Protective Equipment to include:
 - 1) Helmet
 - 2) Breathing Air filter
 - 3) Cool air tube
 - 4) Clothing
 - 5) Noise Level inside the helmet not to exceed 80dBA
 - p. Dust collecting equipment
 - q. Electrical Control Panel
2. Delivery: Drawings shall be submitted for approval not later than 2 weeks after receipt of order. Delivery shall be not later than Twelve (12) weeks after receipt of approved drawings and all pertinent information required for design and production
3. Drawings: Vendor shall furnish the following drawings:
- a. General Arrangement: Vendor shall furnish general arrangement drawings for approval prior to final design.

b. Foundation Drawings: Required anchor bolt and basic pit requirement drawing for use in construction of the foundation.

c. Suggested Ducting Details: Suggested ducting detail for the design of the ducting system and connections.

4. The government will be responsible for: Equipment storage, providing a weather-tight building, foundation/pit requirements, erection/installation of equipment and offloading and handling, electrical power supply and wiring, labor and materials for required for necessary air piping for components; ducting and exhaust/plenum connection required for hook-up of the blast room to the dust collector and exhauster and abrasive.
